- Chief Operating Officer Ilva, the position, which reports directly to the Commissioner's organisational structure, involves the management of all operating units and activities (only the communications and internal auditing departments report directly to the Commissioners). The management targets achieved have balanced current activities (with corporate management in a situation of economic and cash-flow problems linked to reduced production as a result of environmental control) with preparatory activities for transfer of the company branch to the selected bidder in the tender procedure provided for in special administration regulations for major companies. All of this within a situation regulated and contextualised by control by the Creditors' Committee, Court of Milan and Ministry of Economic Development, each in relation to its area of responsibility. Ilva's figures are significant, despite its current limited production levels: a turnover of 3 billion, 14000 direct employees and approximately 5000 workers employed in satellite activities in Taranto and a "Fondo Unitario di Giustizia" bond of 1 billion euro to be used for environmental clean-up activities. Following company leasing, he continues to hold this position within a context of management and control of the contract with the Lessee.
